HELP SECURE EQUALITY FOR FUTURE LGBTQ FLORIDIANS

We know from experience that the path toward full legal and lived equality for LGBTQ Floridians will be full of challenges for the foreseeable future. Equality Florida has been on the forefront of this fight for twenty-five years, and we will continue to be on the forefront for years to come.



A planned gift to Equality Florida¹ helps ensure that we will be there for future generations of LGBTQ Floridians. Your gift will support programs that secure equality for all - that's a very special legacy! And by giving this way, you will join others like you in a group of forward-thinking donors who have made long-lasting commitments to equality.

WAYS TO GIVE

There are a number of ways to include Equality Florida in your estate plan:

Provide for Equality Florida in your Will or Trust. You can transfer many types of assets (cash, cryptocurrencies, appreciated securities, qualified retirement plans, real and personal property) directly through your Will or Trust. To make a bequest in your Will, include the following charitable donation language: "I hereby give and bequeath [specific cash amount, percentage amount, or specific property] to Equality Florida for its general purposes."² To provide for us in a Trust, include language that directs the Trustee to distribute the chosen asset(s) to Equality Florida.



• Make Equality Florida the beneficiary of your life insurance or retirement assets. Most life insurance policies and retirement contracts allow for you to designate one or more beneficiaries that will receive these assets upon your death. Depending on your circumstances, using these planned giving vehicles can provide tax benefits during your lifetime (again, consult a tax specialist). To designate our organization as a beneficiary, include Equality Florida in the appropriate beneficiary designation form.

Prior to finalizing your charitable planned gift, please consult an attorney and/or a financial professional - we are not attorneys. Also, consult our Gift Acceptance Policy (we will be happy to provide a copy). Whenever possible, contact us prior to finalizing any planned gift to Equality Florida, so that we help craft a plan that reflects your interests and ensure that your proposed gift meets our basic criteria.
